

## 3. Bid Price

- a. The contract shall be for the supply of the mentioned items to the KVS,through the Principal K.V.CRPF Pryagraj The bidder shall quote for items in the format of tender attached. Corrections, if any, shall be made by crossing out, initialling, dating and rewriting;
- b. All duties, taxes and other levies payable by the bidder shall be included in the total price. However, the tax and duties leviable should be quoted separately.
- c. The rates quoted by the bidder shall be fixed for the duration of the contract (and shall be quoted in Indian Rupees only);
- d. The prices should be quoted in Indian Rupees only,
- e. Each bidder shall submit only one tender;
- f. Telex or Facsimile tender are not acceptable
- \*g. The bid should be submitted along with EMD for **Rs.12,000/**by bank draft/ Bankers Cheque CBS in **favour of<u>Kendriya</u>Vidyalaya Vidyalaya Vikas Nidhi payable at UBI,Shantipuram,Prayagraj.**
- h. The firm should enclose supporting documents regarding registration of IT/PAN/GST

## 4. Validity of tenders

The tender shall remain valid for a period not less than 90 days after the deadline specified for submission of tenders. Validity of tender -**01 year** from the date of finalization of tender.

## 5. Evaluation of tenders:


The Purchaser will evaluate and compare the tenders determined to be substantially responsive, i.e., which are:

- a) Properly signed, and
- b) Confirm to the terms and conditions and specifications.

The evaluation would be done for each item separately. Purchaser will award the contract to the responsive bidder whose total cost for a particular item is lowest.

#### 6.Award of contract:

- (a) The purchaser will award the contract to the bidder whose tender has been determined to be substantially responsive and who has offered the **lowest price as** per Para 5 above;
- (b) The bidder whose bid is accepted will be notified of the award of the contract by the Office prior to expiration of the tender validity period;
- c) The Notification of Award to clearly specify any change in the unit price or any other terms and conditions accepted.
- (d) Normal commercial warranty/guarantee shall be applicable to the supplied goods;
- (e) Payment shall be made within 30 days after the delivery of goods and their acceptance;
- (f) Notwithstanding the above, the Purchaser reserves the right to accept or reject any tender and to cancel the bidding process and reject all tender at any time prior to the award of the contract.
- (g) Prior to acceptance of the tnder, the undersigned reserves the right to cal for sample or demonstration and the contactor shaal be liable to supply the sample or give the demonstration free of cost.
- (h) The successful bidder has to deposit performance security with the Vidyalaya of the amount of (<u>To</u> <u>be Intimated after finalisation of tender</u>) in favour of <u>Kendriya Vidyalaya Vidyalaya Vikas</u> <u>Nidhi</u> in the form of DD/Bankers Cheque.


